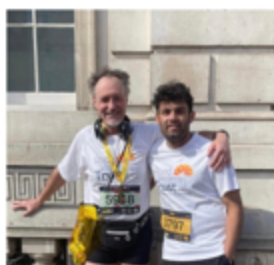


## Welcome to our Fundraising Guide!

Your donation will make a huge difference to the lives of people affected by a road death or serious injury...

**£5 will fund an initial written & verbal consultation with a bereaved person.**

**£10 will cover the cost of postage of bereavement information to families for one week.**

**£20 will fund the cost of two separate one hour counselling sessions with a bereaved person.**

**£50 will cover the hourly cost of external professional supervision for our counselling team.**

**£100 will cover the cost of face to face counselling support for a bereaved family for two months.**

Every £1 is worth £1.25 when the donor is a UK taxpayer - remember to tick the gift aid box!
